Field of activity

GIZ is implementing the Global Program on Sustainable Fishery and Aquaculture in currently four countries (Mauretania, Malawi, Madagascar, Uganda). The program aims to combat food-insecurity by increasing supply of fish and to increase the income of the low-income population. The global program is part of the BMZ special initiative "One World-Zero Hunger" (SEWOH). There are three main activity areas: Improvement of the artisanal fisheries, promotion of sustainable fisheries and reduction of illegal, unreported and unregulated (IUU) fishing. Target groups are vulnerable households and communities, artisanal fishers and small- and medium sized enterprises in the fishing sector. Additional stakeholders are ministries, fisheries organizations and associations.

Within the global program the country component Madagascar is focusing on the following activity areas: improve conditions for the local rice-fish production and aquaculture production in ponds and set-up of a multi-stakeholder platform for the discussion and identification of best practices for a sustainable aquaculture sector in Madagascar.

Your tasks

As the person responsible for the implementation of the country component Madagascar, you will be responsible for the overall management of the component, the supervision of staff, sub-contractors and consultants and the coordination with the steering unit of the Global Program in Eschborn/Bonn on Monitoring & Evaluation (M&E), communication, reporting to Federal Ministry of Economic Cooperation and Development (BMZ) and financial management.

Your field of activity includes the following tasks:

- · Manage the project for the country component Madagascar
- · Supervise a team of experts and consultants
- Coordinate and supervise the implementation of the technical components of the country component Madagascar
- Represent the project in national and international meetings
- Consult with local stakeholders including Ministries, fishermen, associations of the Madagascar aquaculture sector
- Reporting to the BMZ in coordination with the central steering unit in Eschborn/Bonn
- Financial management in coordination with the central steering unit in Eschborn/Bonn
- Implementation of Monitoring & Evaluation system in coordination with the central steering unit in Eschborn/Bonn
